- 2.4 No changes, alterations or modifications hereto shall be effective unless made in writing and signed by the Parties.
- 2.5 The Amendment is compiled in three (3) counterparts in the English language, each of which has the power of an original. Elsevier shall receive one counterpart and the Lead Institution shall receive two counterparts.
- 2.6 The Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and effect under law and

each Contracting Party declares that the electronic execution is valid and effective in the jurisdiction the Contracting Party executes the Amendment.
