WHEREAS

On January 02, 2023 Elsevier and Lead Institution entered into a Elsevier Subscription Agreement (the "**Agreement**") which defines conditions of cooperation and rights and duties of the Parties while providing the Subscribed Products **Science Direct** ® **online - Cell Press Collection** as defined in Schedule 1 of the Agreement. 
1.3 The other provisions of the Agreements shall remain unchanged.

- 2.2 The Amendment shall be binding upon, and inure to the benefit of, the Parties and their respective legal successors and assigns.
- 2.3 The Amendment shall become valid on the date of signature by both Parties. The Amendment comes into effect on the date of its publication in the Register of Contracts under the conditions stipulated by Act No. 340/2015 Coll., On the Register of Contracts, as amended. The Amendment will be published in the Register of Contracts by the Lead Institution.
- 2.4 No changes, alterations or modifications hereto shall be effective unless made in writing and signed by the Parties.
- 2.5 The Parties agree that electronically signed versions of this originally executed Amendment are acceptable in lieu of printed signed copies and are to be given full force and effect under the law and each Party declares that the electronic execution is valid and effective in the jurisdiction the Party executes this Agreement.


